### REQUEST FOR FEEDBACK ON PROPOSED CONSTRUCTION W. MARIPOSA AVE. AND W. PINE AVE. SIDEWALK IMPROVEMENTS PROJECT

Dear Property Owner:

New sidewalks are planned for the public right-of-way (ROW) in front of the 400 block of W. Mariposa Avenue and 300 block of W. Pine Avenue in late June as part of the City’s annual concrete improvements project. The intent of this letter is to help you understand the improvements to be made, and to solicit your feedback regarding the work to be done.

The improvements include:

- Removal of City trees, landscape, and hardscape in the public ROW in both areas and
- On the south side of the 400 block of W. Mariposa Ave., between Virginia St. and the west alley:
  - installation of new sidewalk, curb, and asphalt slot paving next to new concrete
  - installation of a short retaining wall, steps that join private walkways, and handrails
- On the south side of the 300 block of W. Pine Ave., between Virginia St. and Concord St.:
  - installation of new sidewalk and curb, and asphalt slot paving next to new concrete
  - planting of new trees

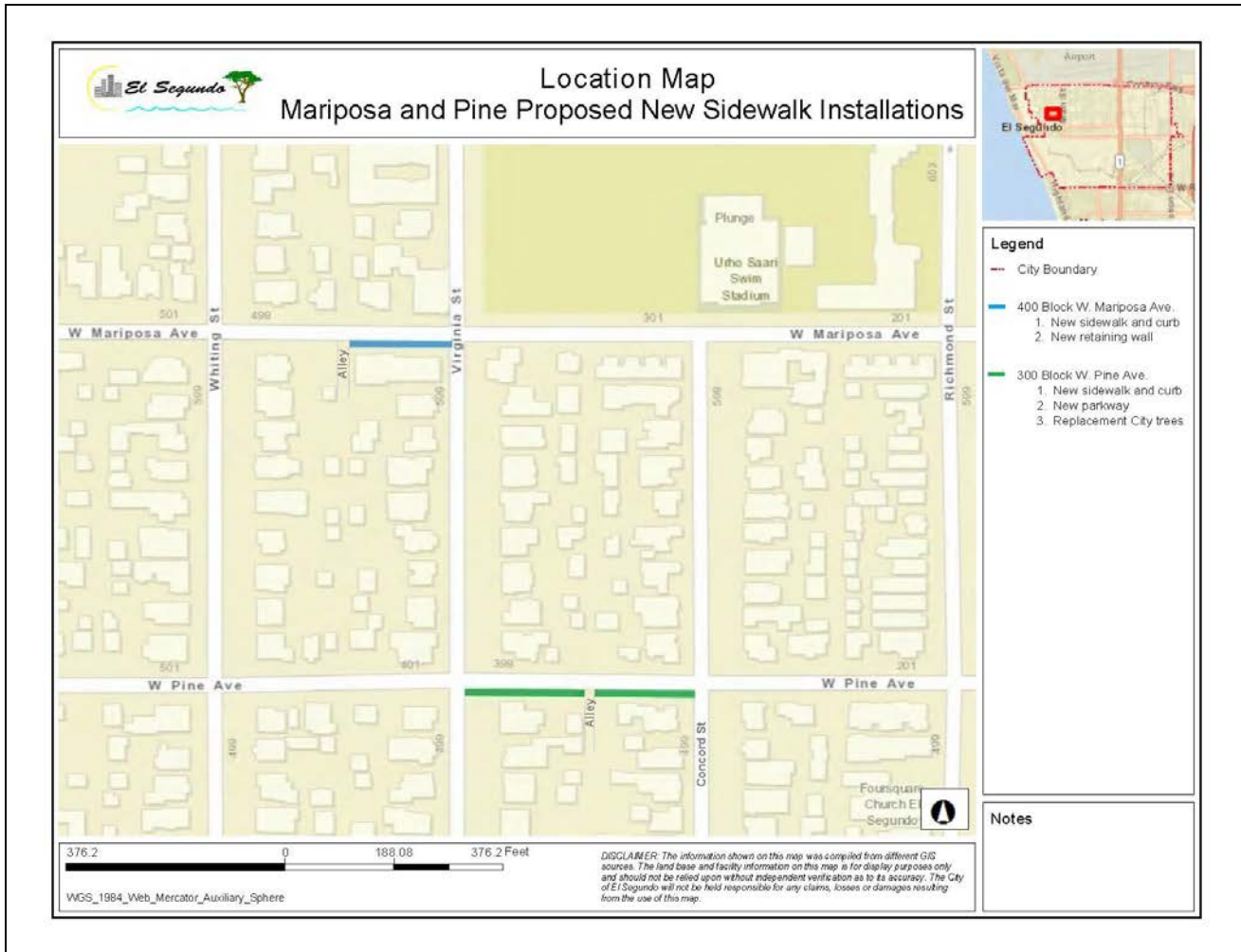
